## Drunk Driving and Your Driver's License

If the arresting officer determines that your blood alcohol content (BAC) is over the legal limit by

"blowing" over .08 on the breathalyzer, your driver's license will be automatically suspended for 3 months after the 46<sup>th</sup> day from the date of the arrest. However, in order to protect your driver's license, you must request an administrative hearing - this is separate from your criminal DUI case. If you fail to request a hearing, your driver's license can be suspended for 3-6 months (first offense DUI), or longer if you have a prior DUI conviction.

**Get Your License Back:** We fight to protect your driving privileges. Also, if your license has been revoked, we petition to rescind (cancel) the license suspension and reinstate your driver's license.
